**TEAM ROPING: 20 Headers & 20 Heelers. \$250 Catalog Fee. PAPERS DUE BY CATALOG DEADLINE or will fill spots from waiting list. These will be the first 40 horses in the sale on Saturday. Competition will be held on Friday August 24. All horses must go through the sale, those who don't show up will be assessed an additional \$250 fee "no exceptions." A commission of 8% will be charged on sale price or last bid on pass outs. The \$250 catalog fee will be Jackpot with nothing held out. 5 places will be paid with all money in the average. Cactus saddles to the average winners. Roping will be a #12 slide, no header under a triad #4+ and no heeler under a triad #5+. Each horse will draw 4 partners. Roping will be progressive after one. 1 rider can ride 2 horses (head or heel).**

Horses that RESIDE INSIDE NEW MEXICO: Upon your arrival to this sale, you must have coggins and brand inspection from YOUR brand inspector. Confirmation letters will go out 3 weeks before the sale and catalogs will be mailed out 2 weeks prior to the sale. It is your responsibility to get your horses to and from the sale ring at its designated time to sell and to feed/water your own horses, hay is available and water tubs. DO NOT DROP OFF YOUR HORSES AND LEAVE, if you can't be here, bring an agent with you to take care of your business. Shavings are available \$7.00 per bag.
